Information about this children's home

The children's home is registered for up to 68 children who have autism spectrum disorders and/or learning disabilities. The service operates as a residential special school that also provides accommodation for 52 weeks of the year. As a result, it is registered as a children's home. The home provides care across 11 houses. The home is owned by a private national organisation.

The effectiveness of the home and the progress and experiences of children and young people since the most recent full inspection

This home was judged requires improvement to be good at the last full inspection. At the interim inspection, Ofsted judges that it has improved effectiveness.

At the last inspection, four requirements and three recommendations were made. Leaders and managers have met three of the requirements and all of the recommendations.

Staffing the children's home with enough permanent staff remains an ongoing issue which does have an impact on the service. Leaders and managers are using several different avenues to recruit. Leaders and managers have recruited 21 new staff since May 2019, but 17 staff have left.

The use of agency staff to cover shifts continues, but the number of different agency staff caring for children has reduced. A new system is in place for the vetting of agency staff which is in line with safer recruitment practices. This process includes looking at the experience of the agency worker against the needs of the children.

The frequency and quality of staff supervision has improved but is not consistent across the staff team. Leaders and managers have identified this and are acting to address this with staff who are responsible for providing supervision.

Leaders and managers are now monitoring the training for all staff effectively, including agency staff. This ensures that staff receive the training that they need to meet the children's needs and for their personal development.

The management of safeguarding concerns is appropriate. Where required, detailed investigations are carried out with clear outcome actions set and lessons learned identified. Leaders and managers need to ensure that all investigations and actions set from them are completed in a timely manner.

There have been medication errors since the previous inspection, and this has been a historical concern. Leaders and managers implemented a new system since the previous inspection, but this has not been effective in reducing errors. Another new system has been developed but is yet to be implemented. A 'failsafe' system needs to be urgently implemented.

Behaviour is managed well. There has been a reduction in the number of restraints used. One example of this is a child's incidents of restraint reducing from 31 in the first six months of this year to eight in the last six months. The monitoring of restraint records has led to an improvement in their quality.

The quality of children's records has improved. These now provide clear information on children's progress and achievements, including work on their independence skills. Staff use photographs to evidence this. These files demonstrate children's involvement in planning their care wherever possible. Included in these records is



good evidence seen of improving activities for children which also link to the achievements and progress being made by the children.

medicine which is prescribed for a child is administered as prescribed to the child for whom it is prescribed and to no other child. (Regulation 23(1)(2)(b))	
In particular, urgently implement a system to ensure that medication is not missed.	

Recommendations

■ The registered person should make best use of information from independent and internal monitoring to ensure continuous improvement. They are responsible for proactively implementing lessons learned and sustaining good practice. ('Guide to



the children's homes regulations including the quality standards', page 55, paragraph 10.24)

In particular, ensure that internal investigations and actions arising from them are completed swiftly to ensure that lessons learned are implemented effectively.

■ The registered person must have systems in place so that all staff, including the manager, receive supervision of their practice from an appropriately qualified and experienced professional, which allows them to reflect on their practice and the needs of the children assigned to their care. ('Guide to the children's homes regulations including the quality standards', page 61, paragraph 13.2)
